Guide to Colonel Hans C. Heg of the 15th Regiment of Wisconsin Volunteers. Mr. Heg enlisted at Waupun, Wisconsin around September 30, 1861 for a 3 year term. He died at Crawfish Springs, Alabama, around September 20, 1863, from wounds he suffered at the Battle of Chickamauga.

Abstract

The following collection of 17 documents were a part of Cornelia Heg's correspondences, records, and sworn testimonies in court by herself and other character witnesses who knew her and her husband, the late Colonel Hans C. Heg . The existing documents detail efforts to update Mrs. Heg's widow's pension enabling her to continue supporting her children. Mrs. Cornelia Heg married Colonel Hans C. Heg on December 10, 1851. Together they had 3 children; James E., Hilda S., and Hans E.E.

BIOGRAPHICAL NOTE:

Born in Norway in 1829, Hans Heg emigrated to America with his family in 1840 and settled in Racine County, Wisconsin. Like his father Evan Heg, Hans served in several capacities within his local government before he was elected warden of the state prison in Waupun, Wisconsin in 1859. When the Civil War started in 1861, Heg resigned from the prison system to return to Racine County to raise the 15th Wisconsin, a regiment almost completely made up of Norwegian immigrants. Heg led the regiment as its colonel at the battles of Perryville and Stones River before he was promoted to brigade command in May of 1863. While leading his brigade at the Battle of Chickamauga on September 19, 1863, Heg was mortally wounded in the abdomen and died in a field hospital the next day. His body was brought back to Wisconsin and buried in the Norway Lutheran Church Cemetery in Racine County. A Racine County park is named in his memory for his bravery leadership to his men during the Civil War.

COLLECTION OVERVIEW

As previously mentioned in the above abstract, the 17 documents include such things as certificate of marriage, birth records of their 3 children, and the character references of former neighbors who lived near the Hegs. They were use to help verify the authenticity and character of Mrs. Cornelia Heg in her attempt to improve her widow's pension in the ongoing challenges of supporting her children.

Noteworthy:	Verifying that Colonel Hans C. Heg enrolled on September 30, 1861, at Racine County, Wisconsin, in the 15 th Regiment of Wisconsin Volunteers to serve 3 years during the war. He was mustered in on the 13 th of February, 1862, at Madison, Wisconsin. He was reported mortally wounded at the Battle of Chicdamauga, on September 19, 1863. Noteworthy:	 That Mrs. Heg, being duly sworn in according to the law applied for pension by the Acts of Congress granting pensions to widows. That she is the widow of Colonel Hans C. Heg. That Colonel Heg was wounded in the Battle of Chickamauga on the 19th-20th of September, 1863. That at the time of his death, Mr. Heg was a commissioned Colonel and married to one Cornelia Jackson on December 10th, 1851, by Geo. Larson, Justice of the Peace. Upon the proofs of Claim Pension #153114 was issued and that at present she remained his widow. That her children by union with Colonel Hans Heg are as follows:

Noteworthy:	That he was personally acquainted with the late Colonel Hans C. Heg and his wife Cornelia Heg who in 1861 were residents of Waupun. That on February 22, 1861 he (Dr. Moore) "was called to attend the accoutrement of said Cornelia Heg". That on that day (mentioned above) he delivered her a male child (repudiated to be said child of Hans C. Heg named Hans E. Heg). That Colonel Hans C. Heg was killed at the Battle of Chickamauga. That I have no interest in this claim

Noteworthy:	 That between the years 1852-1854 she resided at the town of Norway, Racine County, Wisconsin. That she was personally acquainted with Hans C. Heg and his wife Cornelia during those years. That she was also present as a midwife to Colonel Heg in the delivery of a male child. That she also attended on March 2, 1854 "another accoutrement" of Cornelia Heg, a female child named Hilda Heg. That Hans C. Heg was Colonel of the 15th Regiment of Wisconsin Volunteers and was killed at the Battle of Chickamauga.

That she is the mother of James E. Heg born at Norway, Racine County, Wisconsin on September 22, 1852. That Mrs. Gunild Jacobsen was a midwife to her but now maybe dead. That Hilda S. Heg was also born to Cornelia and Hans C. Heg. That Mrs. Kalvine Anderson officiated as midwife on that occasion That Mrs. Anderson may also now be dead. That Hans E. Heg was born to her said late husband at Waupun, Dodge County, Wisconsin. That D.W. Moore attended her at that time.

	That further there is no private or public hospital record of the births of said stated children. That she (Mrs. Cornelia Heg) has not abandoned the care and support of her said children. That they all yet survive with her in Beloit, Wisconsin. That she (Mrs. Cornelia Heg) has not remarried but continues as Hans C. Heg's widow.
	Personally appeared before said Notary, Darwin W. Gregory, and Hilda S. Heg, both Beloit, Wisconsin residents. That they are both acquainted with Cornelia Heg and know her to be the identical person.
