# **BIOGRAPHICAL NOTE**

Garrett Van Fleet was born in Morgan County, Ohio on \_\_\_\_\_\_1824. When he enlisted in Company F, 77<sup>th</sup> Ohio Infantry at age 40, he had been a married farmer with six children. The enlistment notes stated he had a light complexion and stood 5' 7" with black eyes and dark hair. He enlisted on February 11, 1864 in Marietta, Ohio for a three-year term of service. He was captured during the engagement at Marks Mills Arkansas on April 25, 1864. As a result of his 10-month imprisonment, he suffered a variety of physical disorders and applied for a government pension. In 1870 he settled in Wisconsin and died on January 16, 1904 in Forest, Wisconsin.

# 77<sup>th</sup> Ohio Volunteer Infantry

During his membership in the 77<sup>th</sup> Ohio, Garrett Van Fleet would have participated in the work of the regiment. A portion of that regiment's history is attached here for reference purposes.

Organized in the fall of 1861, under Colonel Jesse Hildebrand, it reported to General Sherman at Paducah in February 1862. In April it participated both days in the battle of Shiloh; and took part in the siege of Corinth until the evacuation when it moved westward, operating in Northern Mississippi and arriving at Memphis in July. It was ordered to Alton, Illinois in August, where it remained until July 1863, then moved to Helena, Arkansas. In January 1864, the Regiment reenlisted and went to Ohio on veteran furlough. In March it joined the Red River expedition and met with disaster. It took part in the capture of Mobile and then went to the Rio Grande where it served until mustered out March 8, 1866, the veterans having performed over four years of service. <a href="http://ohiocivilwar.com/cw77.html">http://ohiocivilwar.com/cw77.html</a>

Garrett Van Fleet's regimental service was covered by the following regimental history, taken from Dyer's *Compendium*. *Ohio In The War-Volume II*. Whitelaw Reid. Moore, Wilstach & Baldwin. Cincinnati 1868.

77th Regiment Infantry. Organized at Marietta, Ohio, September 28, 1861, to January 5, 1862. 1st Brigade, 3rd Division, Arkansas Expedition, to January 1864. 1st Brigade, 3rd Division, 7th Army Corps, Dept. of Arkansas, to April 1864. 2nd Brigade, 3rd Division, 7th Army Corps, to May 1864.

After Garrett Van Fleet enlisted as a volunteer, the regiment was involved in the Red River expedition. Van Fleet was part of the Steele expedition, designed to assist General Banks in his efforts.

The regiment had reenlisted December 20, 1863, and mustered in as Veterans January 22, 1864, and moved to Columbus, Ohio. Returned to Little Rock March 1-17. Steele's Expedition to Camden March 23-May 3. Okalona April 2-3. Prairie D'Ann April 9-12. Camden April 15-18. Mark's Mills April 25, most of Regiment captured. Evacuation of Camden April 27.
